Tax-Exempt Status + Budget + Billing

It was announced at the 2018 CELA Annual Conference in March 2018 that CELA had lost its tax-exempt status. The CELA Executive Committee and Board have been working with a non-profit tax specialist to reinstate CELA's tax-exempt status. A current draft timeline for this process is April to August--Reconciliations of IRS tax returns; August--Request for retroactive reinstatement of organizational tax-exempt status.

The review of prior tax returns, budgets and billings have given CELA the opportunity to review and invoice past due memberships and advertisings from previous years. FrameWorks Initiative Update

The President's Council has engaged *The FrameWorks Institute* in an initiative to "reframe" landscape architecture. Invitations have been sent to 15 individuals identified by the Presidents Council for in-depth interviews about the perceptions and practice of landscape architecture. This is the first step in the development of an effective narrative regarding the profession. Interviews are to be completed by July 13.

"FrameWorks designs, conducts, and publishes multi-method, multi-disciplinary communications research to empirically identify the most effective ways of reframing social and scientific topics.
